On 061908 at 0736 hours I responded to Community Hospital for a death investigation. Upon my arrival I made contact with the emergency room staff. They advised Fire Rescue Unit Rescue 12 brought in a thirty-six year old female who was a non-breather and had lividity settled on her back. The female had CPR attempted on her. Fire Rescue told the emergency room staff that they searched the residence and were unable to locate any medications. The female was identified as Laura Bowdoin. Laura's husband George Bowdoin and daughter were in separate waiting rooms.

I then examined the body which was placed in room two in the emergency room. The body had arrived at the emergency room at 0702 hours and a time of death was pronounced at 0708 hours by Doctor Christian, under chart number E00922926754. Laura's body was lying on a stretcher on her back. Her head was turned to the right and had a breathing tube and equipment attached to her mouth. There was an IV attached to her left arm. Her arms were by her sides. Laura was wearing a hospital gown. The emergency room staff said Laura was wearing pink and white sleeping pants, black tank top, and underwear.

Signs of trauma to the body. Lividity was settled on the back of the body. There were no broken blood vessels in the eyes. I shut the door to the room.

Corporal Gracie then notified Sergeant. Sessa of Major Crimes and informed him of the situation. Deputy Izrailov was stationed at the residence on Blue River, since the call was dispatched. I was advised by Corporal Gracie that Major Crimes would not be responding to the hospital or to the residence. I was advised that the Medical Examiner's Office would be responding to pick up Laura's body from the hospital. Corporal Gracie advised me that Deputy Izrailov was released from the scene since the residence was secured and all its inhabitants were at the hospital, and a detective was not responding, and Sergeant Sessa authorized release of the scene. I

was advised by Corporal Gracie that a Forensics Technician was not responding since there was no visible trauma to the body and that the Medical Examiner's Office would take photo's.

I then spoke with George Bowdoin who was being tended to by Hospice counselors. George said he and his wife Laura were going through a divorce since last October. The divorce was Laura's idea.

George said they still slept in the same room till January. Then they started to sleep in separate rooms in the same residence. George said he came home at 2100 hours yesterday and Laura was in the office of the residence working. George said he was putting in for sale post(his company) at residence's till 2100 hours. George said Laura's behavior seemed kind of strange in the fact that she was stumbling around. George said normally they kept their conversations to a minimum. However last night they conversed about how to divide up their property since they would have to hire a mediator for the divorce. They also talked about George's mother sending Laura an email about her causing the divorce and that she did not approve of it. George also asked Laura if she was dating someone and she did not answer.

George said Laura went to bed at approximately 2300 hours. He woke up at 0530 hours. George said he showered, and went to wake Laura up at around 0600 to 0610 hours, so she could shower. George said this is normal routine. George said he opened her door and she never got up. As George continued to get ready, he kept telling Laura to get up and there was still no movement. George said he finally went into the room and turned on a light. When George looked at Laura, he said she did not look right. I asked him what he meant by this and he told me, that she was not moving and it looked strange. When George pulled back the blanket, he saw she was not responding and not breathing. I asked George what position she was in and he said she was lying on her back with her left arm over her chest. Her right arm was by her side, and her head was turned to the right. George then called 911 and they instructed him to do CPR. Laura was not ill and not on any medication. I asked George about alcohol consumption and he told me there was a wine glass in the dishwasher, but he does not know if it was from last night or the previous night.

I then spoke with Ramon who is a neighbor to George and Laura and is a Sergeant with the Clearwater Police Department. Ramon said that he and his wife are friends with the Bowdoins. Ramon said he called in sick so he could tend to his wife who is ill. Ramon went to lay back down in bed when his wife's cell phone

started ringing. Ramon said the number came up as Laura's. When he answered it, it was George on the phone. George told Ramon that he was at the hospital and that Laura was not responding and breathing.

Ramon said that George and Laura had been going through a divorce. Ramon said he also called Laura's mother and Laura's partner. Ramon said he heard rumor that Laura was sleeping with her partner, and that George was aware of it. Ramon provided Corporal Gracie with a number for Laura's partner Jim They were partners at a real estate company. Laura worked at a real estate company and George works at a Cadillac dealership. However they also own a company that installs for sale posts at homes that are for sale.

Rick Altdoerffer from the Medical Examiner's Office responded to the scene. He removed Laura's body and clothing from the hospital room. Child left with Ramon. George stayed in the waiting room with the Hospice counselor.

Later in the day Corporal Gracie kept receiving phone messages from Jim I called Jim back. Jim said he was concerned that Laura's death was suspicious. Jim said that he spoke to Laura the night before and she did not seem to be herself. I advised Jim that my investigation was concluded and being forwarded to the Major Crimes Unit and for him to contact them.

A wants and warrants check was conducted on Laura and George Bowdoin, and had negative results. I have taken no further action.
