INVESTIGATION

I was assigned this case on 6/19/08 and it was administratively cleared on 6/23/08 pending the results of toxicology from the Medical Examiner's Office. In the mean time I had spoken to several individuals who felt they had information that might be important in regards to the death of the deceased Laura Bowdoin who was thirty six years old.

After reading the original report generated by Deputy Tucker I made contact with Deputy Tucker who advised me that he had responded to the hospital and did not go to the residence of the deceased. I made contact with Deputy Izrailov who advised he was in the driveway of the residence but never did go inside the residence as there was nothing that was to be considered suspicious known at this point for there to be a crime scene considered. Deputy Izrailov advised he was notified by his supervisor to leave the scene which he did. A supplement was completed by Deputy Izrailov.

I made contact with Jim [redacted] who was a business partner of the deceased.

INTERVIEW (via telephone)

Jim who was emotionally distraught upon our interview at approximately 1430 hours on 06/23/08 said he felt Laura's husband George Bowdoin was responsible for her death. Jim advised me that Laura was afraid of her husband and that her husband got angry very easily. Jim
